

2018 MEMBERSHIP PRIZE DRAW CONTEST OFFICIAL RULES

HERE'S HOW IT WORKS:

The contest opens at 9:30 AM on November 13, 2018 and closes at midnight on December 30, 2018.

Required for Entry: Participants must purchase or renew their Vancouver Aquarium Membership prior to entering the contest and provide their current contact information (e-mail, address, telephone number).

A different prize will be drawn each week of the contest period. A winner will be chosen at random on the Monday of each week the contest runs.

The selected entrant will be contacted by email with instructions for collecting prize and will be given a one-week deadline from time of contact to collect their prize. If the prize is not claimed, another winner will be selected at random.

ELIGIBILITY

This contest is open to anyone either purchasing a Vancouver Aquarium Membership or renewing their existing Vancouver Aquarium Membership. Contest is open to residents of Canada, excluding Quebec, who are Vancouver Aquarium Members in good standing. Employees and volunteers of Ocean Wise Conservation Association ("Sponsor") and its respective, affiliates, subsidiaries, advertising and promotion agencies (collectively the "Promotion Entities") and the immediate family members and/or those living in the same household as such person, are not eligible. All federal, provincial and local laws and regulations apply.

ENTRY PERIOD:

The contest will run from 9:30 AM on November 13, 2018 until midnight on December 30, 2018. The winners will be selected by noon on the Monday of each week the contest runs. Only the entries received in the prior week are eligible for each week's draw.

TERMS OF SUBMISSION:

By participating in the Contest, each entrant agrees to be bound by these Rules and by the interpretation of these Rules by the Sponsor.
